BOARD MEETING REPORT

 ${\bf March}$ 13, 2024 ${\bf Special}$ ${\bf Meeting}$ — The SSIPB Board held a special meeting and discussed the following:

Treasurer Bill Carmichael presented a financial report. Currently SSIPB has about \$20,000 in the bank pending the results of the Pickle Paddle Battle tournament. Current club membership stands at 164, down somewhat from the 2023 total of 203 (it's not to late to join!).

The Board voted to provide food for the Grand Opening event at the new North Glynn courts as well as offer the use of the club's PA system and tent. Mary Kline has offered to make trophies for the tournament that is to be part of the event.

Bill Carmichael also reported on the upcoming Pickle Paddle Battle Tournament and the Spring League. The Board agreed to look into the possibility of hosting a tournament at the North Glynn Complex in October and to also continue our fundraising tournament in November at the Kings Park Courts. The Board is developing ideas for a potential charitable cause for the November tournament.

The Board heard committee reports from Board liaisons; Suzi Hassel, Social Committee, Bill Carmichael, Competition Committee, and Murray Pounds, Public Relations Committee (see Page 3 for more committee info).

Murray Pounds reported on a meeting with Glynn County staff to discuss the possibility of developing more dedicated pickleball courts in Glynn County. Hopefully more discussions are forth-coming.

The next Board meeting is scheduled for Wednesday, April 10, 10:00 a.m. in Room 112 of the Casino Building.

DO YOU KNOW ABOUT THESE RULES?

Here are some of the changes in the 2024 version of the rules:

"Carrying" the ball, meaning that it does not bounce away from the paddle, but stays on the face of the paddle for an extended period, is now considered a fault, regardless of whether or not it was intentional.

If a referee or player stops a rally to correctly identify that a player is in the wrong position, the rally shall be replayed. If the rally is stopped incorrectly, the player doing so is at fault. If the rally is completed the results stand even if a player started the rally in the wrong position.

Even if you suspect the ball you are playing with is cracked during a rally, the rally should continue until it ends. If both teams agree that a broken or cracked ball impacted a rally, a replay occurs.

GRAND OPENING HELD FOR NEW COURTS AT NORTH GLYNN RECREATION COMPLEX

At long last the conversion of four tennis courts at the North Glynn Recreation Complex to twelve pickleball courts has been completed. The new courts look fabulous and will be appreciated by pickleball players throughout Glynn County.

To celebrate the completion of the courts a "Grand Opening" event was held Saturday, March 23. Despite a wet start to the morning, nearly 100 pickleball players of varying skill and abilities participated in the event. The day began with Open Community Play followed by a series of beginner and intermediate clinics taught by local players. Along the way attendees had the opportunity to grab a hot dog and a bag of chips. Throughout the day there were drawings for prizes including hats, visors, insulated cups and even a brand new (and very nice) Franklin paddle.

For those of you unfamiliar with the North Glynn courts, play will be governed by the Community Play rules established by Glynn County Parks and Recreation. These rules require players to engage only in doubles play when there are others waiting to play and no courts are available. Players should play a standard 11 point game (win by 2) and then vacate the court for the next group waiting to use a court. When finished with a game players can then stack their paddles for the next available court. No singles, lessons, drilling, or use of ball machines is allowed when players are waiting.

Open Community Play sessions typically occur Monday, Wednesday Friday and Saturday from 8:30—11:00 a.m. Evening sessions are held Tuesday and Thursday from 6:00—8:00 p.m. Players of all skills and abilities are encouraged to participate in these sessions.
